AgSouth Farm Credit, ACA Management's Discussion and Analysis of Financial Condition and Results of Operations

The following commentary reviews the financial condition and results of operations of AgSouth Farm Credit, ACA (Association) for the period ended September 30, 2022. This information should be read in conjunction with the accompanying financial statements, notes to the financial statements, and the 2021 Annual Report of AgSouth Farm Credit, ACA. The accompanying consolidated financial statements were prepared under the oversight of the Audit Committee of the Board of Directors.

FORWARD LOOKING INFORMATION

This quarterly report contains forward-looking statements. These statements are not guarantees of future performance and involve certain risks, uncertainties and assumptions that are difficult to predict. Words such as "anticipates," "believes," "could," "estimates," "may," "should," "will," or other variations of these terms are intended to identify the forwardlooking statements. These statements are based on assumptions and analyses made in light of experience and other historical trends, current conditions, and expected future developments. However, actual results and developments may differ materially from our expectations and predictions due to a number of risks and uncertainties, many of which are beyond our control. These risks and uncertainties include, but are not limited to:

- political, legal, regulatory and economic conditions and developments in the United States and abroad;
- economic fluctuations in the agricultural, rural utility, international, and farm-related business sectors;
- weather-related, disease, and other adverse climatic or biological conditions that periodically occur that impact agricultural productivity and income;
- changes in United States government support of the agricultural industry; and
- actions taken by the Federal Reserve System in implementing monetary policy.

LOAN PORTFOLIO

The Association provides funds to farmers, rural homeowners and farm-related businesses for financing of short and intermediate-term loans and long-term real estate mortgage loans. The Association's loan portfolio is diversified over a wide range of agricultural commodities produced in our region, including timber, poultry (broilers, turkeys and eggs), sod, nursery and horticulture, cotton, feed grains, soybeans and hay, beef cattle, horses, peanuts, blueberries, fruits, and nuts. Loans to producers of these commodities total \$1,789,308 or 86.02 percent of the Association's portfolio. Farm size varies, and many of the Association's customers have diversified farming operations. These factors, along with the numerous opportunities for non-farm income in the area, reduce to some degree the level of income dependency on any given commodity.

AGRICULTURE OVERVIEW

The top three agricultural commodities by repayment source in the AgSouth Farm Credit, ACA portfolio are broilers, timber, and cotton. The purpose of this section is to give an overview of the top three agricultural commodities and other matters regarding other commodity groups as needed.

Broilers – In the National Agriculture Statistics Service's (NASS) report for the week ending October 1, 2022, domestic broiler growers placed 189 million chicks for meat production which is up 6 percent from a year ago. In Georgia, 26.4 million broiler chicks were placed which is the same as a year ago. South Carolina had 5.2 million broiler chicks placed which represents an 8.5 percent increase from last year.

Timber – According to the third quarter 2022 Market Report by TimberMart-South south-wide average stumpage prices decreased for all major pine products but increased for the major hardwood products. The movement in price on both pine and hardwood products is typical historically in the third quarter.

Cotton – In the NASS report for crop progress for the week ending October 2, 2022, Georgia and South Carolina cotton bolls have nearly finished opening and some harvest has taken place. Georgia is at 81 percent bolls opened and 9 percent harvested while South Carolina is at 75 percent bolls opened and 7 percent harvested. Both states are in line with historical averages in terms of progress of the crop. Cotton in South Carolina is rated 70 percent good or better, 21 percent fair, and 9 percent poor to very poor. Georgia cotton is rated 64 percent good or better, 28 percent fair, and 8 percent poor to very poor.

Hurricane Ian Update – Hurricane Ian had the potential to impact farms and borrowers in Southeastern Georgia and the Lowcountry region of South Carolina. Reports from both states were growers rushed to harvest peanuts dug prior to the storm and defoliated cotton. Southeast Georgia was relatively unaffected by the rain and winds from Hurricane Ian as the storm moved further east before heading north into South Carolina. Early reports in the Lowcountry region of South Carolina indicated light to moderate cotton loss depending on the amount of cotton open and row direction related to the wind.

ASSOCIATION BALANCE SHEET

The gross loan volume of the Association as of September 30, 2022 was \$2,080,073 an increase of \$48,402 or 2.38 percent compared to \$2,031,671 at December 31, 2021. Net loans outstanding at September 30, 2022 were \$2,064,326 as compared to \$2,013,959 at December 31, 2021. Net loans accounted for 96.36 percent of total assets at September 30, 2022, as compared to 95.02 percent of total assets at December 31, 2021.

The increase in gross loan volume during the reporting period is attributed to the funding of operating lines of credit and term loans during the busiest time of the growing season. Advances on most operating lines are now funded and additional anticipated growth in the portfolio is being realized. Competition for good quality loans remains strong from some commercial banks, but the Association has remained competitive in a difficult rate environment.

The Association typically structures loans to meet the needs of the borrower. Many term loans are made for ten years or less allowing the borrower to build equity faster and thus reducing the risk in the loan portfolio.

At September 30, 2022 Investments in debt securities totaled \$3,602, a decrease of \$154 from December 31, 2021. The 4.10 percent decrease is from payments received in 2022. At December 31, 2021 the Association held Investments in debt securities totaling \$3,756. These investments are Rural America Bonds made under the authority for Mission Related Investments granted by the Farm Credit Administration (FCA).

There is an inherent risk in the extension of any type of credit. Portfolio credit quality is at an acceptable level and credit administration remains satisfactory. Nonaccrual loans decreased from \$12,133 at December 31, 2021 to \$11,625 at September 30, 2022. The balance of nonaccrual loans is decreased by loans returning to accrual status, liquidations, or transfer of assets to other property owned offset by transfers to nonaccrual status. Association staff is working diligently to work out all nonaccrual debt situations.

Association management maintains an allowance for loan losses in an amount considered sufficient to absorb possible losses in the loan portfolio based on current and expected future conditions. The allowance for loan losses at September 30, 2022 was \$15,747 compared to \$17,712 at December 31, 2021 and was considered by management to be adequate to cover possible losses. Although management has

not recognized any direct decline in credit quality, an adjustment to the qualitative factors seemed prudent given the financial climate. The reserve set aside for unfunded commitments is \$253 which is a decrease of \$285 compared to the total at December 31, 2021 of \$538. The reserve for unfunded commitments is included in Other liabilities. The Asset/Liability Committee (ALCO) of the Association, which is comprised of members of executive management and staff assigned to special assets management, met in June 2022 to review the allowance account. The ALCO determines the composition between the allowance for loan losses on the outstanding portfolio and the reserve required for unfunded commitments. The ALCO considered the general economic conditions, the potential for deterioration in the existing portfolio, the loan growth in the portfolio, and the amount of outstanding loan commitments in determining the level of allowance.

As of the end of the third quarter of 2022, the Association had originated \$218,772 in loans for the secondary market. Originations for the same period 2021 were \$232,451. The 5.88 percent decrease is due to increased home prices and building costs which has slowed down home purchases and construction. As of September 30, 2022 the Association held \$585 in qualifying Loans held for sale. At December 31, 2021 loans held for sale totaled \$4,236.

Accrued interest receivable increased \$2,770 or 17.81 percent from \$15,555 as of December 31, 2021 to \$18,325 as of September 30, 2022. The increase is related to the higher loan volume at September 30, 2022 compared to December 31, 2021.

Equity investments in other Farm Credit institutions increased from \$20,688 at December 31, 2021 to \$21,310 at September 30, 2022. The increase of \$622 or 3.01 percent is the result of a higher balance of investment in other Farm Credit institutions, which varies based on participations sold on a patronage basis.

Premises and equipment, net decreased \$727 from \$20,717 at December 31, 2021 to \$19,990 at September 30, 2022. The primary reason for the decrease of 3.51 percent is due to depreciation on assets.

Other property owned decreased to \$36 at September 30, 2022 from \$215 at December 31, 2021. The decrease of \$179 or 83.26 percent in Other property owned is the result of the sales and write-downs of Other property owned exceeding the acquisitions of Other property owned during the reporting period.

Accounts receivable decreased \$25,235 from \$36,947 at December 31, 2021 to \$11,712 at September 30, 2022. The decrease is the result of the patronage distribution receivable at December 31, 2021 from AgFirst and other Farm Credit institutions, which totaled \$14,777 in regular distribution and \$21,523 in a special distribution. As of September 30, 2022

this line item included three quarters of patronage accrual from AgFirst and other Farm Credit institutions totaling \$11,245.

Other assets decreased from \$2,711 at December 31, 2021 to \$2,495 at September 30, 2022. The majority of other assets is made up of prepaid retirement expense which totaled \$1,337 as of September 30, 2022.

On the liability side of the balance sheet, Notes payable to AgFirst Farm Credit Bank increased from \$1,617,876 at December 31, 2021 to \$1,650,480 at September 30, 2022. The \$32,604 or 2.02 percent increase is tied to the increase in loans outstanding.

Accrued interest payable increased \$770, or 22.84 percent, from \$3,371 at December 31, 2021 to \$4,141 at September 30, 2022. The increase is due to the increase in the notes payable balance outstanding.

Patronage refunds payable decreased \$32,335 from \$32,431 at December 31, 2021 to \$96 at September 30, 2022. The decrease is the result of the 2021 All Cash Patronage Distribution on the Association's records at December 31, 2021 moving from Patronage refund payable to Other liabilities. This amount totaled \$32,000 at December 31, 2021. Checks were mailed to customers during the first quarter of 2022. No patronage distribution had been declared for 2022 as of September 30, 2022.

Accounts payable increased \$514 from \$3,067 at December 31, 2021 to \$3,581 at September 30, 2022. The 16.76 percent increase is due to the payable established to resolve disputed claims and to pay the insurance premiums on loans to the Farm Credit System Insurance Corporation (FCSIC). At December 31, 2021 the payable related to the FCSIC totaled \$2,298, and at September 30, 2022 the payable was \$2,214.

Other liabilities increased \$3,196 from \$15,224 at December 31, 2021 to \$18,420 at September 30, 2022. The 20.99 percent increase is due to the 2021 All Cash Patronage Distribution and the revolvement of the 2016 series allocated surplus checks that were distributed to Association members. This balance will decrease as checks are presented at the commercial bank.

Capital stock and participation certificates increased from \$11,107 at December 31, 2021 to \$11,221 at September 30, 2022. The increase of \$114 or 1.03 percent is due to new borrowers purchasing stock during the reporting period in excess of liquidations of stock when loans pay out.

Allocated surplus decreased from \$121,081 at December 31, 2021 to \$101,191 at September 30, 2022. This is a decrease of \$19,890 or 16.43 percent. The reduction is from the decision made by the Board of Directors to revolve the 2016 series of allocated surplus in January 2022.

Unallocated surplus increased \$37,577 or 11.84 percent from the December 31, 2021 balance of \$317,250. The balance of \$354,827 at September 30, 2022 includes the retention of a portion of 2021 fiscal year end earnings and earnings year to date in 2022.

Accumulated other comprehensive loss decreased \$390 or 20.17 percent from the December 31, 2021 balance of \$1,934. At September 30, 2022 there was a balance of \$1,544.

RESULTS OF OPERATIONS

For the three months ended September 30, 2022

Net income for the three months ended September 30, 2022 totaled \$13,386 as compared to \$12,011 for the same period in 2021. This is an increase of \$1,375 or 11.45 percent. Comprehensive income for the three months ended September 30, 2022 was \$13,516 compared to \$12,017 for the same period in 2021. Employee benefit plans adjustments are responsible for the difference between comprehensive income and net income. The following commentary explains the variance.

At September 30, 2022 interest income on loans increased \$2,755 from \$27,037 at September 30, 2021 to \$29,792 at September 30, 2022. This increase of 10.19 percent is primarily due to an increase in loan volume and interest rates between the two reporting periods.

For the three months ended September 30, 2022 interest income on investments totaled \$63 compared to \$66 for the three months ended September 30, 2021. Investment income declined \$3 or 4.55 percent due to the lower outstanding balance of investments between the two reporting periods.

Interest expense for the three months ended September 30, 2022 increased \$2,302 from \$9,993 at September 30, 2021 to \$12,295 at September 30, 2022. The variance of 23.04 percent is tied to the weighted average direct note rate between the two reporting periods.

Net interest income before the reversal of allowance for loan losses increased \$450 for the three months ended September 30, 2022 as compared to the same period in 2021. The increase is due primarily to the higher interest income between the two reporting periods.

Net interest income after the reversal of allowance for loan losses increased \$2,144 during the quarter ending September 30, 2022 compared to September 30, 2021. A reversal of allowance for loan losses of \$968 was made in the quarter ending September 30, 2022. The reversal of allowance for loan losses entry represents an adjustment between the general provision and the unfunded commitments provision which is booked to Other liabilities. Noninterest income decreased \$432 over the same period last year. The commentary that follows will detail the aggregate difference.

Loan fees decreased \$422 or 30.34 percent, due to the discontinuation of the Small Business Administration's Paycheck Protection Program during the height of the pandemic in which the Association earned fees on those loans.

Fees for financially related services increased \$285 from \$520 at September 30, 2021 to \$805 at September 30, 2022. The increase of 54.81 percent is due to the increase in crop insurance and leasing services income earned during the reporting period.

Patronage refunds from other Farm Credit institutions increased \$93 from \$3,864 at September 30, 2021 to \$3,957 at September 30, 2022. The increase of 2.41 percent is due to an increase in patronage distribution from AgFirst on participations sold. See *Note 2* for more information.

Gains on the sale of rural home loans decreased \$418 from \$1,067 at September 30, 2021 compared to \$649 at September 30, 2022. The decrease is due to the decrease in volume of Secondary Mortgage Markets sold.

Gains on the sale of premises and equipment, net for the period ending September 30, 2022 totaled \$160 compared to \$14 for the period ending September 30, 2021. The Association sold more fleet vehicles in 2021 compared to 2022.

Losses on other transactions totaled \$78 at September 30, 2022 compared to a Gains on other transactions of \$123 at September 30, 2021. This difference is due to a liability being established for \$1,600 and offsetting loss to resolve disputed claims.

Other noninterest income was \$157 during the three months ended September 30, 2022 compared to \$72 for the three months ending September 30, 2021. This line item consists of fees received from Secondary Mortgage Market referrals and settlement fund payments received.

Noninterest expense for the three months ended September 30, 2022 totaled \$11,761 and increased \$391 or 3.44 percent when compared to \$11,370 for the same period of 2021. Salaries and employee benefits expense is the largest portion of noninterest expense and totaled \$7,797 for the three months ended September 30, 2022. Salaries and employee benefits decreased \$800 between the two reporting periods. There is a 9.31 percent variance between the two reporting periods due to the decrease in the fair market value of retirement plans as well as the lower expected funding cost of the pension plan for the current year.

Occupancy and equipment expense at September 30, 2022 was \$563 compared to \$585 for the same period in 2021. This is a decrease of \$22 or 3.76 percent. The decrease is tied to the reclassification of property tax expenses.

The Insurance Fund premiums at September 30, 2022 were \$761 and at September 30, 2021 were \$586. The \$175 or 29.86 percent increase is due to the higher premium assessment rate in 2022.

Purchased Services at September 30, 2022 were \$798 and at September 30, 2021 were \$399. The \$399 or 100.00 percent increase is due to the increased closing costs in relation to the growth in loan volume.

Data processing expense at September 30, 2022 was \$129 compared to \$112 for the same period in 2021. This is an increase of \$17 or 15.18 percent. The increase is tied to higher data processing servicing costs.

Other operating expenses increased \$494 from \$1,222 at September 30, 2021 compared to \$1,716 at September 30, 2022. The increase of 40.43 percent is attributed to an increase in directors expense, travel, Association vehicles, and marketing activities.

In the three months ending September 30, 2022 the Association experienced Gains on the sale of other property owned in the amount of \$3. During the same period of 2021, the Association booked Gains on the sale of other property owned of \$131. The gain is the result of sales exceeding any write-downs during the third quarter.

For the nine months ended September 30, 2022

Net income for the nine months ended September 30, 2022, totaled \$37,577 as compared to \$36,548 for the same period in 2021. This is an increase of \$1,029 or 2.82 percent. Comprehensive income for the nine months ended September 30, 2022 was \$37,967 compared to \$36,566 for the nine months ended September 30, 2021. Employee benefit plans adjustments are responsible for the difference between comprehensive income and net income. The following narrative will explain the variance.

At September 30, 2022 interest income on loans increased \$4,656 to \$84,227 compared to \$79,571 for the same period in 2021. The increase is tied to growth in loan volume and the increase in the overall weighted average interest rate earned.

For the nine months ending September 30, 2021 interest income on investments totaled \$200 compared to \$190 for the same period ended September 30, 2022. Investment income declined \$10 or 5.00 percent due to the lower outstanding balance of investments between the two reporting periods.

Interest expense increased \$3,613 or 12.35 percent from \$29,257 at September 30, 2021 to \$32,870 for the nine months ended September 30, 2022. The net increase is attributable to a higher direct note balance between the reporting periods.

Net interest income before the provision for loan loss increased \$1,033 or 2.04 percent for the nine months ended September 30, 2022 as compared to the same period in 2021 primarily due to the increase in loan volume. Net interest income after the provision for loan losses increased \$4,188 for the period ending September 30, 2022 due to an increase in loan volume and provision expense reversal.

The Provision for loan losses amount in the 2021 reporting period totaled \$853 and there were reversal entries totaling \$2,302 in the 2022 reporting period. In September 2022, the Association's ALCO made the decision to decrease the allowance requiring a decrease to the general reserve and the allowance for unfunded commitments which resides within Other Liabilities. These decisions were made after analyzing the risk in the current portfolio. The ALCO analysis included reviewing historical trends, loan size, loan performance, and credit quality reports.

Noninterest income for the nine months ended September 30, 2022 decreased \$1,277 compared to the same period of 2021. Loan fees decreased \$1,206 or 25.17 percent. The decrease is due to a decrease in SMM originations and fees received from SBA PPP Loans that has been discontinued.

Fees for financially related services increased \$485 from \$1,237 at September 30, 2021 compared to \$1,722 at September 30, 2022. The 39.21 percent increase in fees for financially related services is the result of an increase in fee income earned on the sale of crop insurance policies.

The patronage refunds from other Farm Credit institutions increased \$885 from \$11,297 at September 30, 2021 to \$12,182 at September 30, 2022. The increase of 7.83 percent is due to an increase in patronage distribution from AgFirst on participations sold.

Gains on the sale of rural home loans increased \$37 from \$2,450 at September 30, 2021 to \$2,487 at September 30, 2022. Gains increased due to the higher interest rate environment compared to this time in 2021.

Gains on the sale of premises and equipment increased \$166 from \$144 for the period ending September 30, 2021 to \$310 at September 30, 2022. The increase is the result of the increased resell value of Association vehicles sold during the period.

Losses on other transactions totaled \$1,575 for the nine months ended September 30, 2022 compared to gains of \$311 for the same period in 2021. The losses recorded in the 2022 reporting period are primarily related to a liability established to settle disputed claims.

Other noninterest income increased \$242 from \$195 at September 30, 2021 compared to \$437 at September 30, 2022. The variance of 124.10 percent is due to volume premiums paid by AgFirst for secondary market activity and settlement payments received.

Noninterest expense for the nine months ended September 30, 2022 increased \$1,942 compared to the same period of 2021 from \$33,486 to \$35,428. Salaries and employee benefits expense decreased \$345 between the two reporting periods. The 1.37 percent decrease in salaries and employee benefits is tied to the decrease in pension expense. The Association accrues for the 2022 incentive payment based upon plan results which are included in salary and benefit expense. The Association evaluated 2022 performance measures for incentive purposes and determined that some employees could earn incentive in 2022. Based upon this information, the Association will continue to accrue for incentive. The expense associated with the incentive accrual balance as of September 30, 2022 is \$3,150. Association results will be reevaluated prior to the end of the fourth quarter 2022 to determine the most accurate accrual for the 2022 incentive plan.

Occupancy and equipment expense at September 30, 2022 was \$1,542 compared to \$1,811 for the same period in 2021. The decrease is tied to the reclassification of property taxes.

The Insurance Fund premiums increased from \$1,705 at September 30, 2021 to \$2,214 at September 30, 2022. The increase of \$509 or 29.85 percent is due to the higher insurance fund premium rate in 2022 compared to 2021.

Purchased Services totaled \$1,669 for the nine months ending September 30, 2022. This is an increase of \$557 or 50.09 percent compared to the nine months ending September 30, 2021 total of \$1,112. The increase is due to the increased closing costs in relation to the growth in loan volume.

Data Processing increased \$37 or 11.14 percent from \$332 for nine months ending September 30, 2021 compared to \$369 for nine months ending September 30, 2022. The increase is tied to the purchase of telecommunication services.

Other operating expenses increased \$1,322 from \$3,426 at September 30, 2021 compared to \$4,748 at September 30, 2022. The increase is primarily due to director, training, and marketing expenses that were not realized in 2021 due to the COVID-19 pandemic.

Gains on other property owned, net totaled \$26 for the nine months ending September 30, 2022. When compared to the same period in 2021, gains on other property owned totaled \$157. These amounts are due to the gains recognized on the sale of other property owned exceeding any write-downs.

FUNDING SOURCES

The principal source of funds for the Association is the borrowing relationship established with AgFirst Farm Credit Bank (the Bank) through a General Financing Agreement. The General Financing Agreement utilizes the Association's credit and fiscal performance as criteria for establishing a line of credit on which the Association may draw funds. The Bank advances the funds to the Association in the form of notes payable. The notes payable are segmented into variable rate and fixed rate sections. The variable rate note is utilized by the Association to fund variable rate loan advances and operating funds requirements. The fixed rate note is used specifically to fund fixed rate loan advances made by the Association. The total notes payable to the Bank at September 30, 2022 was \$1,650,480 as compared to \$1,617,876 at December 31, 2021. The \$32,604 increase of 2.02 percent, is directly tied to the increase in loan volume.

CAPITAL RESOURCES

Total members' equity at December 31, 2021 totaled \$447,504. At September 30, 2022 total members' equity had increased by \$18,191 to \$465,695. The increase in total members' equity is due to an increase in Unallocated retained earnings between the two reporting periods. At December 31, 2021 Allocated retained earnings totaled \$121,081 compared to \$101,191 at September 30, 2022. The decrease is due to the revolvement of the 2016 series of allocated surplus in the first quarter of 2022. At December 31, 2021 Unallocated retained earnings totaled \$317,250 and increased to \$354,827. The increase in Unallocated retained earnings is due to the decision to retain a portion of the 2021 earnings for capital purposes and year to date 2022 earnings.

Total Capital stock and participation certificates were \$11,221 on September 30, 2022 compared to \$11,107 on December 31, 2021. The increase is attributed to the purchase of new stock and participation certificates for new borrowing entities offset by the retirement of stock and participation certificates on loans liquidated in the normal course of business.

The Association's capital ratios are calculated in accordance with FCA regulations, as follows:

- The CET1 ratio is the sum of statutory minimum purchased borrower stock, other required borrower stock held for a minimum of 7 years, allocated equities held for a minimum of 7 years or not subject to revolvement, unallocated retained earnings, paid-in capital, less certain regulatory required deductions including the amount of investments in other System institutions, divided by average risk-adjusted assets.
- The tier 1 capital ratio is CET1 capital plus non-cumulative perpetual preferred stock, divided by average risk-adjusted assets.
- The total capital ratio is tier 1 capital plus other required borrower stock held for a minimum of 5 years, subordinated debt and limited-life preferred stock greater than 5 years to maturity at issuance subject to certain limitations, allowance for loan losses and reserve for unfunded commitments under certain limitations less certain investments in other System institutions under the corresponding deduction approach, divided by average riskadjusted assets.
- The permanent capital ratio is all at-risk borrower stock, any allocated excess stock, unallocated retained earnings, paid-in capital, subordinated debt and preferred stock subject to certain limitations, less certain investments in other System institutions, divided by PCR risk-adjusted assets.
- The tier 1 leverage ratio is tier 1 capital, divided by average assets less regulatory deductions to tier 1 capital.
- The UREE leverage ratio is unallocated retained earnings, paid-in capital, and allocated surplus not subject to revolvement less certain regulatory required deductions including the amount of allocated investments in other System institutions divided by average assets less regulatory deductions to tier 1 capital.

If the capital ratios fall below the minimum regulatory requirements, including the buffer amounts, capital distributions (equity redemptions, dividends, and patronage) and discretionary senior executive bonuses are restricted or prohibited without prior FCA approval.

REGULATORY MATTERS

On April 14, 2022, the FCA approved a final rule that amends certain regulations to address changes in accounting principles generally accepted in the United States. Such changes reflect the Current Expected Credit Losses (CECL) methodology that will replace the incurred loss methodology upon adoption. Credit loss allowances related to loans, lessor's net investments in leases, and held-to-maturity debt securities would be included in a System institution's Tier 2 capital up to 1.25 percent of the System institution's total risk weighted assets. Credit loss allowances for available-for-sale debt securities and purchased credit impaired assets would not be eligible for inclusion in a System institution's Tier 2 capital. The regulation does not include a transition phase-in period for the CECL day 1 cumulative effect adjustment to retained earnings on a System institution's regulatory capital ratios. In addition, the regulation does not include an exclusion for the CECL day 1 cumulative effective adjustment from the "safe harbor" deemed prior approval provision. The final rule is effective on January 1, 2023.

On August 26, 2021, the FCA issued a proposed rule to revise its regulatory capital requirements to define and establish riskweightings for High Volatility Commercial Real Estate (HVCRE) by assigning a 150 percent risk-weighting to such exposures, instead of the current 100 percent. The proposed rule would ensure that the FCA's rule remains comparable with the capital rule of other federal banking regulatory agencies and recognizes the increased risk posed by HVCRE exposures. The public comment period ended on January 24, 2022.

LIBOR Transition

The Association has exposure to LIBOR arising from loans made to customers and Systemwide Debt Securities issued by the Funding Corporation on the Bank's behalf.

The FCA has issued guidelines with similar guidance as the US prudential regulators but applicable for System institutions to follow as they prepare for the expected phase-out of LIBOR. The guidelines direct each System institution to develop a LIBOR transition plan designed to provide an orderly roadmap of actions that will reduce LIBOR exposure, stop the inflow of new LIBOR volume, and adjust operating processes to implement alternative reference rates.

The Association has implemented LIBOR transition plans and continues to analyze potential risks associated with the LIBOR transition, including, but not limited to, financial, market, accounting, operational, legal, tax, reputational, and compliance risks. See the Association's 2021 Annual Report for further discussion on the LIBOR transition. The LIBOR transition plan includes implementing fallback language into variable-rate financial instruments maturing after June 30, 2023 which provides the ability to move these instruments to another index if the LIBOR market is no longer viable.

Note 1 — Organization, Significant Accounting Policies, and Recently Issued Accounting Pronouncements

Organization

The accompanying financial statements include the accounts of AgSouth Farm Credit, ACA and its Production Credit Association (PCA) and Federal Land Credit Association (FLCA) subsidiaries (collectively, the Association). A description of the organization and operations, the significant accounting policies followed, and the financial condition and results of operations for the Association as of and for the year ended December 31, 2021 are contained in the 2021 Annual Report to Shareholders. These unaudited interim consolidated financial statements should be read in conjunction with the latest Annual Report to Shareholders.

Basis of Presentation

In the opinion of management, the accompanying consolidated financial statements contain all adjustments necessary for a fair statement of results for the periods presented. These adjustments are of a normal recurring nature, unless otherwise disclosed.

Certain amounts in the prior period's consolidated financial statements have been reclassified to conform to the current period presentation. Such reclassifications had no effect on the prior period net income or total capital as previously reported.

The results of any interim period are not necessarily indicative of those to be expected for a full year.

Significant Accounting Policies

The Association's accounting and reporting policies conform with US generally accepted accounting principles (GAAP) and practices in the financial services industry. To prepare the financial statements in conformity with GAAP, management must make estimates based on assumptions about future economic and market conditions (for example, unemployment, market liquidity, real estate prices, etc.) that affect the reported amounts of assets and liabilities at the date of the financial statements, income and expenses during the reporting period, and the related disclosures. Although these estimates contemplate current conditions and expectations of change in the future, it is reasonably possible that actual conditions may be different than anticipated, which could materially affect results of operations and financial condition. Management has made significant estimates in several areas, including loans and allowance for loan losses (Note 2, *Loans and Allowance for Loan Losses*), investment securities and other-than-temporary impairment (Note 3, *Investments*), and financial instruments (Note 6, *Fair Value Measurement*). Actual results could differ from those estimates.

For further details of significant accounting policies, see Note 2, *Summary of Significant Accounting Policies*, from the latest Annual Report.

Accounting Standards Effective During the Period

There were no changes in the accounting principles applied from the latest Annual Report.

Note 2 — Loans and Allowance for Loan Losses

The Association maintains an allowance for loan losses at a level considered adequate by management to provide for probable and estimable losses inherent in the loan portfolio as of the report date. The allowance for loan losses is increased through provisions for loan losses and loan recoveries and is decreased through loan charge-offs and allowance reversals. A review of individual loans in each respective portfolio is performed periodically to determine the appropriateness of risk ratings and to ensure loss exposure to the Association has been identified. See Note 3, *Loans and Allowance for Loan Losses*, from the latest Annual Report for further discussion.

Credit risk arises from the potential inability of an obligor to meet its repayment obligation. The Association manages credit risk associated with lending activities through an assessment of the credit risk profile of an individual obligor. The Association sets its own underwriting standards and lending policies that provide direction to loan officers and are approved by the board of directors. Note 3 — Investments

Investments in Debt Securities

The Association's investments consist primarily of Rural America Bonds (RABs), which are private placement securities purchased under the Mission Related Investment (MRI) program approved by the FCA. In its Conditions of Approval for the program, the FCA generally considers a RAB ineligible if its investment rating, based on the internal 14-point risk rating scale used to also grade loans, falls below 9 and requires System institutions to provide notification to FCA when a security becomes ineligible. Any other bonds purchased under the MRI program, approved on a case-by-case basis by FCA, may have different eligibility requirements. At September 30, 2022 the Association held no RABs whose credit quality had deteriorated beyond the program limits.

The recording of an impairment is predicated on: (1) whether or not management intends to sell the security, (2) whether it is more likely than not that management would be required to sell the security before recovering its costs, and (3) whether management expects to recover the security's entire amortized cost basis (even if there is no intention to sell). If the Association intends to sell the security or it is more likely than not that it would be required to sell the security, the impairment loss equals the full difference between amortized cost and fair value of the security. When the Association does not intend to sell securities in an unrealized loss position and it is not more likely than not that it would be required to sell the securities, other-than-temporary impairment loss is separated into credit loss and non-credit loss. Credit loss is defined as the shortfall of the present value of the cash flows expected to be collected in relation to the amortized cost basis.

The Association performs periodic credit reviews, including other-than-temporary impairment analyses, on its investment securities portfolio. The objective is to quantify future possible loss of principal or interest due on securities in the portfolio.

The Association has not recognized any credit losses as any impairments were deemed temporary and resulted from noncredit related factors. The Association has the ability and intent to hold these temporarily impaired investments until a recovery of unrealized losses occurs, which may be at maturity, and at this time expects to collect the full principal amount and interest due on these securities, especially after considering credit enhancements.

Equity Investments in Other Farm Credit System Institutions

Equity investments in other Farm Credit System institutions are generally nonmarketable investments consisting of stock and participation certificates, allocated surplus, and reciprocal investments in other institutions regulated by the FCA. These investments are carried at cost and evaluated for impairment based on the ultimate recoverability of the par value rather than by recognizing temporary declines in value.

Associations are required to maintain ownership in AgFirst (AgFirst or the Bank) in the form of Class B or Class C stock as determined by the Bank. The Bank may require additional capital contributions to maintain its capital requirements. The Association owned 6.60 percent of the issued stock of the Bank

as of September 30, 2022 net of any reciprocal investment. As of that date, the Bank's assets totaled \$41.7 billion and shareholders' equity totaled \$1.6 billion. The Bank's earnings were \$313 million for the first nine months of 2022. In addition, the Association held investments of \$4,358 related to other Farm Credit institutions.

Note 4 — Debt

Notes Payable to AgFirst Farm Credit Bank

The Association's indebtedness to the Bank represents borrowings by the Association to fund its earning assets. This indebtedness is collateralized by a pledge of substantially all of the Association's assets. The contractual terms of the revolving line of credit are contained in the General Financing Agreement (GFA). The GFA also defines Association performance criteria for borrowing from the Bank, which includes borrowing base margin, earnings and capital covenants, among others.

Note 6 — Fair Value Measurement

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability in an orderly transaction between market participants in the principal or most advantageous market for the asset or liability.

Accounting guidance establishes a hierarchy for disclosure of fair value measurements to maximize the use of observable inputs, that is, inputs that reflect the assumptions market participants would use in pricing an asset or liability based on market data obtained from sources independent of the reporting entity. The hierarchy is based upon the transparency of inputs to the valuation of an asset or liability as of the measurement date. A financial instrument's categorization within the hierarchy tiers is based upon the lowest level of input that is significant to the fair value measurement.

The classifications within the fair value hierarchy are as follows:

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 inputs include quoted prices for similar assets and liabilities in active markets; quoted prices in markets that are not active; and inputs that are observable, or can be corroborated, for substantially the full term of the asset or liability. Level 3 inputs are unobservable and supported by little or no market activity. Valuation is determined using pricing models, discounted cash flow methodologies, or similar techniques, and could include significant management judgment or estimation. Level 3 assets and liabilities also could include instruments whose price has been adjusted based on dealer quoted pricing that is different than the third-party valuation or internal model pricing. For a complete discussion of the inputs and other assumptions considered in assigning various assets and liabilities to the fair value hierarchy levels, see the latest Annual Report to Shareholders.

There were no Level 3 assets or liabilities measured at fair value on a recurring basis for the periods presented. The Association had no transfers of assets or liabilities into or out of Level 1 or Level 2 during the periods presented.

Fair values are estimated at each period end date for assets and liabilities measured at fair value on a recurring basis. Other Financial Instruments are not measured at fair value in the statement of financial position, but their fair values are estimated as of each period end date. Uncertainty in Measurements of Fair Value

Discounted cash flow or similar modeling techniques are generally used to determine the recurring fair value measurements for Level 3 assets and liabilities. Use of these techniques requires determination of relevant inputs and assumptions, some of which represent significant unobservable inputs as indicated below. Accordingly, changes in these unobservable inputs may have a significant impact on fair value.

Certain of these unobservable inputs will (in isolation) have a directionally consistent impact on the fair value of the instrument for a given change in that input. Alternatively, the fair value of the instrument may move in an opposite direction for a given change in another input. Where multiple inputs are used within the valuation technique of an asset or liability, a change in one input in a certain direction may be offset by an opposite change in another input having a potentially muted impact to the overall fair value of that particular instrument. Additionally, a change in one unobservable input (that is, changes in certain inputs are interrelated with one another), which may counteract or magnify the fair value impact.

Investment Securities

The fair values of predominantly all Level 3 investment securities have consistent inputs, valuation techniques and correlation to changes in underlying inputs. The models used to determine fair value for these instruments use certain significant unobservable inputs within a discounted cash flow or market comparable pricing valuation technique. Such inputs generally include discount rate components including risk premiums, prepayment estimates, default estimates and loss severities.

These Level 3 assets would decrease (increase) in value based upon an increase (decrease) in discount rates, defaults, or loss severities. Conversely, the fair value of these assets would generally increase (decrease) in value if the prepayment input were to increase (decrease). Generally, a change in the assumption used for defaults is accompanied by a directionally similar change in the risk premium component of the discount rate (specifically, the portion related to credit risk) and a directionally opposite change in the assumption used for prepayments. Unobservable inputs for loss severities do not normally increase or decrease based on movements in the other significant unobservable inputs for these Level 3 assets.

Inputs to Valuation Techniques

Management determines the Association's valuation policies and procedures. The Bank performs the majority of the Association's valuations, and its valuation processes are calibrated annually by an independent consultant. The fair value measurements are analyzed on a quarterly basis. For other valuations, documentation is obtained for third party information, such as pricing, and periodically evaluated alongside internal information and pricing that is available.

Quoted market prices are generally not available for the instruments presented below. Accordingly fair values are based on judgments regarding anticipated cash flows, future expected loss, current economic conditions, risk characteristics of various financial instruments, and other factors. These estimates involve uncertainties and matters of judgment, and therefore cannot be determined with precision. Changes in assumptions could significantly affect the estimates.

Quantitative Information about Recurring and Nonrecurring Level 3 Fair Value Measurements

With regard to nonrecurring measurements for impaired loans and other property owned, it is not practicable to provide specific information on inputs as each collateral property is unique. System institutions utilize appraisals to value these loans and other property owned and take into account unobservable inputs such as income and expense, comparable sales, replacement cost and comparability adjustments.

Expenses in the above table are computed using allocated estimates of funding for multi-employer plans in which the Association participates. These amounts may change when a total funding amount and allocation is determined by the respective Plan's Sponsor Committee. Also, market conditions could impact discount rates and return on plan assets which could change contributions necessary before the next plan measurement date of December 31, 2022.

Further details regarding employee benefit plans are contained in the 2021 Annual Report to Shareholders.

Note 8 — Commitments and Contingent Liabilities

From time to time, legal actions are pending against the Association in which claims for monetary damages are asserted. On at least a quarterly basis, the Association assesses its liabilities and contingencies in connection with outstanding legal proceedings utilizing the latest information available. A settlement recognized in June 2022 was resolved in July 2022 in the amount of \$1,600. The amount was reflected as loss on other transactions.

While the outcome of legal proceedings is inherently uncertain, on the basis of information presently available, management, after consultation with legal counsel, is of the opinion that the ultimate liability, if any, from these actions, would not be material in relation to the financial position of the Association.

Note 9 — Merger Activity

On May 24, 2022, the Board of Directors of the Association and Carolina Farm Credit, ACA signed a letter of intent to merge the two Associations. The merger is subject to AgFirst, FCA, and shareholder approval. If approved by all required parties, the merger is expected to take effect upon the commencement of business on April 1, 2023.

Note 10 — Subsequent Events

The Association evaluated subsequent events and determined there were none requiring disclosure through November 8, 2022, which was the date the financial statements were issued.
