Incumbents Re-elected to Board of Directors

The following directors were re-elected at the Association's annual meeting, held in August:



ARTHUR BLACK, of York County, S.C., is a peach, strawberry, hay and produce farmer. He operates a retail roadside market and bakery with his wife and daughter. He is president of York County Farm Bureau and serves on the board of the Fruit Advisory Committee of the South Carolina Farm Bureau. Black also serves

as president on the board of Farmers Mutual Insurance and is a member of the York Investment Association. He has been a director of the Association for 21 years.



CHARLES C. RUCKS, from Fayette County, Ga., is a retired dairy farmer. He also produces hay and raises beef cattle. Rucks is president of the Spalding County Farm Bureau and serves as a board member for the Upper Flint Water Council. He has been a director of the Association for 28 years.



JAMES C. CARTER of Henry County, Ga., is a beef cattle, hay, blueberry, blackberry and strawberry farmer. He has expanded his operation to include agritourism with a corn maze and educational field trips. He also operates a feed business and provides artificial insemination services for cattle. Carter is

the Vice President of the Henry County Farm Bureau, the board chairman of the Henry County Water and Sewage Authority, and serves on the board of the Henry County Cattlemen's Association. He also serves on the board of directors of the AgFirst Farm Credit Bank and the Farm Credit Council. Carter is vice chairman of AgSouth's board of directors and has served the Association for 37 years.



SEAN LENNON, of Meriwether County, Ga., is the owner of Fitzgerald Fruit Farms, LLC, where he grows peaches, blackberries, and strawberries and operates a commercial packing operation. He also contracts for various processors of fruit products. Lennon is the vice president of the Georgia Peach Commodity

Commission, is on the board of the Meriwether County Farm Bureau and is a member of the North Carolina Blue Ridge Apple Growers Association Lennon is also a member of the Georgia Peach Council, the Georgia Agribusiness Council, and Georgia Fruit and Vegetable Growers Association. He has been a director of the association since 2017.

Overtaxing of Georgia's Family-Owned Farms

Family-Owned Farms, AgSouth and Other Farm Credit Associations Lead Support of Legislation to Prevent Overtaxing of Georgia's Family-Owned Farms

Legislation drafted by a workgroup headed by AgSouth Farm Credit's Christian Taylor and sponsored by Senator Tyler Harper (R-GA-007), Georgia HB 290, passed the Georgia Senate 51-0 this spring and was subsequently signed into law by Governor Nathan Deal.

The Equipment Leasing and Financial Association (ELFA), and a group comprised of representatives from AgSouth Farm Credit, AgGeorgia Farm Credit, Southwest Georgia Farm Credit (the Georgia Farm Credit Associations), Farm Credit Leasing, Co-Bank, and John Deere – worked closely with Ga. Rep. Sam Watson (R-Moultrie), a member of the House Agriculture & Consumer Affairs Committee, for several years to develop the legislation.

This measure addresses a personal property tax dilemma that has faced Georgia's family-owned farms for more than 10 years, namely, inconsistent application, by both local assessors and state auditors, of the personal property tax exemption for equipment with a lease-purchase agreement. The ELFA-backed legislation provides for consistent treatment across the state and ensures that certain farm equipment owned or leased by family farmers in Georgia will be exempt from property tax as intended by O.C.G.A. § 48-5-41.1.



The historic Orange Grove Plantation is located on Capers Creek on St. Helena Island in Beaufort County, S.C.

The entrance to the plantation house is lined with a grand stand of moss-covered live oak trees. The planted fields of corn and tomatoes, combined with the lush foliage of magnolias, pines, and hardwoods make a colorful landscape. With a place on the National Register of Historic Places, Orange Grove joins 40 other St. Helena Island plantations that are old enough to have seen colonial times when the main crops were indigo and Sea Island cotton.

In the early 1960's, John M. Trask, Sr., a businessman and farmer, purchased Orange Grove Plantation as part of his vegetable farming operation. Included was a plantation house which became the home of his son, John M. Trask, Jr., who has lived there since 1964 with his wife Caroline where they raised their four children. Over the years, Trask has made extensive improvements to the house and landscape.

Three years ago, he established South Carolina's first commercial citrus orchard, planting over 400 trees consisting of satsuma, kumquats,

grapefruit, lemons, and several varieties of oranges.

The citrus groves have a drip irrigation system. For frost protection, there is a high rise sprinkler system in addition to frost protection blankets.

The sales outlet for the crop is the Charleston-based Grow Foods Carolina Cooperative which has been established to assist Lowcountry farmers. The products are distributed to high-end grocery stores and gourmet restaurants.

Trask, in a bit of humor, said, "We are moving the citrus belt north from Florida!"


